PANAMA PAPERS FIRM



News of the leak from the Panamanian law MOSSACK firm Mossack Fonseca is still breaking. The so-

called Panama Papers show how the firm helped well-heeled clients launder money, dodge sanctions, and avoid taxes.

The firm has over 500 employees in more than 40 offices around the world and, in 2013, had billings of more than \$42 million. The firm claims that it "has never

been accused or charged in connection with criminal wrongdoing," and a spokesman said that the firm "merely helps clients incorporate companies."

Founder Jürgen Mossack's father was a member of the SS during WWII who may have spied on communists for the U.S. after the war. The other founder. Ramón Fonseca, is an award-winning novelist.

Past shenanigans include the crafting of legislation for Niue in 1994 that provided for incorporating offshore companies. The firm then signed a 20-year deal with Niue government for exclusive rights to register such companies. So brisk was their business that in 2001, they were paying \$1.6 million into the country's projected \$2 million annual budget. After an investigation and blacklisting of Niue by the Financial Action Taskforce, Niue declined to renew MF's companies, shutting down the firms exclusive franchise. As a result, the firm encouraged clients to re-incorporate in Samoa.
